

## STUDY CONTRACT

(Hereinafter referred to as “the university”.)

### **§ 1 Objects of the Agreement**

- (1) This agreement is intended to determine the rights and obligations of the parties hereto, and to guarantee that, by adhering to these provisions, the Student attains the academic goal and academic title within the projected time frame as foreseen in the curriculum for the Baccalaureate Programme in Psychotherapy Science.
- (2) In accordance with the Austrian Accreditation Law, the University declares that it has been granted accreditation as a private university for Degree Programmes in Psychotherapy Science and that it is authorized, within the scope of this license, to award academic degrees equal to those awarded by Austrian state universities.
- (3) The notification of accreditation, the relevant curriculum as well as the relevant University Statutes and Regulations accessible to the Student constitute an integrated part of this agreement.

### **§ 2 Obligations of the University**

- (1) The University commits itself to implementing the curriculum as agreed upon and authorized by the AQ Austria. It expressly reserves the right to amend the curriculum in the event that adjustments to national or EU legislation or changes in academic staff become necessary, which shall not be detrimental to the achievement of the projected academic goal in any way.
- (2) In the event the University is forced, for whatever reasons, to discontinue the programme of study, it is obligated to guarantee that all examinations taken and skills acquired by the Student up to that point shall be credited in accordance with the European Credit Transfer System (ECTS).

### **§ 3 Obligations of the Student**

- (1) The Student shall actively participate in the lectures and seminars designed for the Baccalaureate Degree Programme as set forth in the relevant curriculum, and shall abide by the relevant University Statutes and Regulations.
- (2) The Student is obliged to keep all matters pertaining to his/her studies and work performed in placement organisations and at the University's outpatient clinic confidential, in accordance with the regulations set forth by the respective organisation and pertinent data protection legislation.
- (3) The University shall have free and unrestricted access to any work performed and research outcome obtained by the Student as well as to any research results gained by the Student as part of a research project and within the scope of his/her studies.

#### **§ 4 Place of Performance**

The place of performance for all claims arising out of this agreement shall be the university premises.

#### **§ 5 Duration of Contract / Early Termination**

- (1) This agreement shall be in force for the duration required to obtain a Baccalaureate Degree in Psychotherapy Science, that means in 6 semesters at least.
- (2) The parties to this agreement shall be entitled to terminate this agreement prematurely at the end of every semester (31.1. and 31.08.) by giving a two months' notice:
  1. The student may terminate this agreement without giving reasons.
  2. The university may terminate this agreement early by resolution of the rector's office. This agreement may be terminated especially in the event of:
    - a. Grave or repeated breaches of any provisions as laid down in the university statutes and regulations
    - b. A student's failure to achieve the educational goal or a part of the training objectives as specified in the curriculum
    - c. Incomplete payment of university tuition fees, in which case the university shall have the right to claim payment of any outstanding tuition fees until termination of this agreement.

#### **§ 6 Applicable Law and Jurisdiction**

This agreement and any disputes which may arise in connection with it shall be governed by Austrian law. The parties hereto submit to the exclusive jurisdiction of the competent court in Vienna.

#### **§ 7 Severability Clause**

In the event that any or more provisions contained herein shall be held to be invalid, this shall not affect any other provisions of this agreement. The parties hereto shall at once replace any such invalid condition with a valid provision that most closely matches the original aim of this agreement. The same procedure shall apply for any or more loopholes contained in this agreement.

## **§ 8 Amendments to the Agreement**

Any amendments to this agreement as well as termination of it shall be made in writing. Likewise, any request for modification of the written form shall be given in writing.

## **§ 9 Tuition Fees and Payment**

The tuition fees for the Baccalaureate Degree Programme PTS amount to € 6.940,- per semester.

The total amount payable by the Student is six times the amount of the fees payable for one semester. Exceeding the minimum duration of study by a total of one year per degree program does not change the total fees.

In case of exceeding the minimum duration of studies by more than one year per degree program, the university reserves the right to charge further tuition fees (except in justified cases such as pregnancy, illness).

Falling below the personal study duration while maintaining the same ECTS performance does not change the tuition fees.

Tuition fees shall become due at the commencement of each semester and may also be paid in instalments.

The university is entitled to increase tuition fees in the event that the Austrian Consumer Price Index (VPI) rate 12/2011 should rise by more than five percent. The adjusted amount payable shall be rounded up to the nearest EUR 10,-. Such an adjustment of fees shall become effective at the commencement of the subsequent semester.
